#### Comment by Michael C H Jones

In the period 2005/06 Chamber formulated a new policy for the promotion of the Greater Sydney Municipality. The region was divided into five (5) zones for the purpose of linking strategic Chinese cities on the Yangtze:

- A) Eastern Sydney/CBD Nanjing
- B) Northern Sydney/Newcastle Wuhan
- C) Southern Sydney/Wollongong Changqing
- D) Central Sydney/Parramatta Shanghai/Pudong
- E) Western Sydney/Lithgow Chengdu

The first MOU signing was with the CPC Deputy General Secretary Nanjing at the Sydney Town Hall on 31st March 2006 -

The third with the Chongqing Vice Mayor in Sydney on 22nd February 2010

The fourth in early February 2012 with Chengdu.

The fifth, Shanghai/Pudong, has proved difficult because of the Brisbane/Queensland relationship but ACCCI is still progressing it - partly through the Sydney-Shanghai Society (SSS).

Now in a Sydney City Municipality of 43 mayors, not to mention the Greater Region from Newcastle to beyond Wollongong and the Blue Mountains, there are a lot of turf wars and personality conflicts. The Lord Mayor of Sydney, which is really the CBD, is always accused of 'grand-standing and hubris' in seeking to represent the city internationally - not only by other mayors but also by State Governments of whichever colour. Apart from the mirth of having a Sydney 'water-bubbler' mayor sit alongside great cities' mayors from the USA, EU and PRC, Chamber has always believed these situations bring NSW and Australia into contempt and most importantly underline the missed economic opportunities of peer relationships. In terms of authority and powers who would a visiting Great City Mayor speak to/negotiate with - the State Premier is at another 'provincial' level of government.

However in Australia the State Governments effectively remain supreme. That is why the December 2011 published 'NSW 2021 Baseline Report' is so important - it sets the goals and moves towards the criteria for the economic performance of New South Wales and especially Sydney over the next decade.

In this context there has been an upsurge in recent debate on the future of Sydney in part created by:

- \* COAG Constitutional Recognition of Local Government
- \* Federal Government Urban Policy Forum re advice on the future shape of cities

- \* NSW Government new Minister for Local Government Don Page wants legislation to strengthen the role of regional organisations of councils
- \* Australian Centre of Excellence for Local Government Regional Development Australia (RDA) Committees
- \* NSW Business Chamber Help Sydney prepare for the future by creating 10 super councils

Over at least the next 3/5 years the Chamber will be honing the work of its Policy Committees since their reorganisation/establishment around 1995. As one generation of leaders completes it's contribution to Australia China Economic Relations the ACCCI legacy will include a reasonably ordered ship - and the Greater Sydney Municipality is what might be called a Key Priority.

This 'crusade' was begun by a robust contribution to a NSW Business Chamber "Turning Ideas into Action" business roundtable on 20th September 2011 at Chamber's old haunt, the Sydney Shangri-La Hotel. I went head to head with former 12 years Sydney Lord Mayor and NSW State Minister for Planning Frank Sartor and NSW Business Chamber CEO Stephen Cartwright. Stephen was confident that the recently elected Barry O'Farrell State Government would be receptive to their '10 Big Ideas to Grow NSW' campaign including council amalgamations. Frank was sceptical given his long time experience. Both were for a 'softly-softly' approach unlike myself. I argued strongly throughout the afternoon that there needed to be appointed a Minster for Greater Sydney, and if not one of the three senior ministers made responsible for bringing Sydney structurally into the 20th century at least. Asking for 21st century vision might be a little too much.

In my view the regular misfeasance identified by the NSW Independent Commission Against Corruption (ICAC), and the damage it does to Sydney's business reputation internationally, can in part be rectified by a more structurally professional organisation of Greater Sydney Municipal Government. The State Government responsibilities are currently shared between the Premier - Minister for Western Sydney, Deputy Premier - Minister for Trade and Investment, Treasurer, and Minister for Local Government with other ministers having responsibilities for the Hunter, Central Coast and Illawarra. No minister is truly internationally focused on Sydney as one of the great cosmopolitan financial centers of the world. It has always been and remains a lack of vision concerning the implications of institutional globalism.

Perhaps ACCCI can assist the thinking and activism to free Sydney from the constraints of Federation and other State jealousies so as to permit a leading role for our city in the fora of Global Cities as regularly announced on the ACCCI Website Homepage.

To begin further research and study are required into structural change to facilitate the international relations possibilities of Councils of the Greater Sydney Municipality:

1) Greater Sydney - East (initially Nanjing but the Lord Mayor wanted Chongqing - both MOUs signed in Sydney)
